As a part of the admissions process, Students are required to acknowledge that they have read all of CWDI's policies and procedures and agree to adhere to any new or amended policies and procedures.

This policy will be applied in a way that ensures procedural fairness, and applies to all CWDI students in all of CWDI's living and learning environments. All students are responsible for compliance with the Academic Integrity & Expulsion Policy, which may be amended from time to time. This policy may also apply to off campus conduct, if the conduct in question affects the safety, integrity, and/or other interests of Chapleau Lodge and/or CWDI communities.

### **Misconduct**

The behaviours set out below are examples of misconduct that are considered violations to the Academic Integrity & Expulsion Policy. This list is not intended to be a complete list of all possible inappropriate behaviour. In particular, students should be aware that any behaviour by a student which in any way unreasonably interferes with the rights of another member of CWDI will be deemed to be a violation of this policy.

- No student shall engage in disruptive conduct, which impacts or affects any service, function, or act of CWDI or Chapleau Lodge staff or guests.

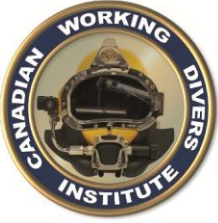

- No student shall misuse, destroy, vandalize or otherwise damage CWDI/Chapleau Lodge property, or any property that is not the person's own while on such property.
- No student shall use, remove and/or abuse any facility, equipment, materials or services without proper authority from a CWDI instructor or Chapleau staff.
- No student shall use technology to download, distribute, or send discriminatory and/or harassing material.
- No student shall use recording devices in classrooms or on CWDI/Chapleau Lodge premises without the permission of CWDI and/or those being recorded

## **Aggressive, Threatening or Offensive Behaviour:**

No student shall:

- Threaten harm to any member of the CWDI/Chapleau Lodge community in any manner, including but not limited to electronic communications originating from personal property not present on CWDI/Chapleau premise;
- Act in any bullying or intimidating manner to any other member of the CWDI/Chapleau Lodge community;
- Act in a manner that is physically or verbally aggressive including and not limited to racism to any other member of the CWDI/Chapleau Lodge community;
- Commit an act of sexual violence against another person or threaten another person with sexual violence. This includes, but is not limited to: sexual assault, sexual harassment, stalking, indecent exposure, voyeurism, degrading sexual imagery, distribution of sexual images or video without consent, cyber harassment and cyber stalking;
- Create a situation which endangers or threatens the safety of themselves or others;
- Incite behaviour that, if undertaken, would constitute a breach of violation of this policy; or
- Display any writing, pictures, or graphics, or use language or dangerous gestures, or engage in any behaviour, which ought reasonably to be known to be obscene.

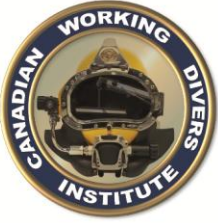

- Illegally use, possess or distribute a controlled or restricted substance
- Consume alcohol while younger than the legal age of consumption as defined by the Liquor License Act

- Possess or use CWDI/Chapleau Lodge property or property belonging to any member of the CWDI/Chapleau Lodge community without the permission of the rightful owner.

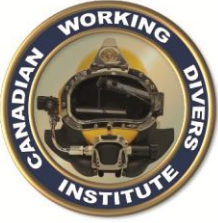
## **Weapons and Unauthorized Possession:**
